AGENDA ITEM 4.C: For Possible Action: Discussion and possible action regarding an application for a Tavern/Bar Liquor License (LIQUOR-005868-2020) with Alicia Rios-Marquez as the liquor manager for NOE RIOS CASTILLO (A General Partnership) dba MIAMI VIBES located at 248 E WINNIE LN STE 448, Carson City, NV 89706.

Recommendation: Deny the Tavern/Bar Liquor License (LIQUOR-005868-2020) with Alicia Rios-Marquez as the liquor manager for NOE RIOS CASTILLO dba MIAMI VIBES located at 248 E WINNIE LN STE 448, Carson City, NV 89706, based on the finding that the applicant failed to complete the background investigation and therefore, cannot be found to be suitable for the issuance of a liquor license.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code. Per CCMC 4.13.125(1) the denial of a liquor license must be made based on the finding that and applicant is unsuitable for the issuance of a liquor license.

The subject request is for NOE RIOS CASTILLO (A General Partnership) to have a Tavern/Bar Liquor License with Alicia Rios-Marquez as the liquor manager.

The Sheriff's Office began the background investigation on Ms. Marquez in March of 2021. Between March of 2021 and January 27, 2022 the Sheriff's Office had, on several occasions, requested Ms. Marquez provide the necessary information to complete the background investigation. On February 2, 2022, the Sheriff's Office issued a memorandum informing the Business License Division that the background investigation is considered incomplete due to the applicant's failure to provide requested documentation.





The Sheriff's Office has conducted a background investigation on the above applicant for a liquor license and has found the following;

- **Background of premises:** The location of Miami Vibes is planned to be located at 248 E Winnie Lane, #448. The applicant and his sister, Alicia Rios Marquez, who is his business partner stated that the location of the Bleu Café is being split into multiple suites but the construction and health inspections have not been completed. The opening date is unknown at this time. A business check of the location was done by CCSO Sgt. Smith who found the location still to be under construction.
- **Financial arrangements:** Mr. Rios is investing approximately \$10,000 of personal monies and his sister stated that she is responsible for purchasing any equipment needed. The amount of the lease is unknown at this time and will not be determined until the renovation/construction has been completed.
- **Method of operation:** Miami Vibes will operate as a bar selling beer, wine and hard liquor and will be open six days a week. The location will employ two persons with Alicia Rios Marquez working full time. Mr. Rios plans on commuting back and forth from his home in California at this time. Ms. Rios Marquez informed me that they are planning on leasing an area for gaming machines and that they will have a DJ on occasion. There will be no food service other than bar snacks.

- **Results of background:** The criminal background for Noe Castillo Rios has been completed which consisted of DMV records, law enforcement agency checks, Nevada criminal history, credit report and fingerprint responses from the FBI and State of Nevada. The information obtained did not find any disqualifying factors for a liquor license based on criteria listed in CCMC 4.13.125.





The Sheriff's Office has conducted a background investigation on the above applicant for a liquor license and has found the following:

- **Background of premises:** Miami Vibes will be located at 248 E Winnie Lane, #448 and is currently under renovation. The suite where the Bleu Café' is located is being split into multiple suites. Ms. Rios Marquez is the second applicant applying as the liquor manager for this business; the first applicant was Noe Castillo Rios, Ms. Marquez's brother, who currently lives in Hollister California. A business check of the location was previously performed by Sgt. Smith who found the location still under construction.
- **Financial arrangements:** Ms. Rios-Marquez's brother, her business partner, is investing approximately \$10,000 of his personal monies and Ms. Rios-Marquez stated that she is responsible for purchasing any equipment needed. The amount of the lease remains unknown and will not be determined until the renovation has been completed and square footage determine.
- **Method of operation:** Miami Vibes will operate as a bar selling beer, wine and hard liquor and will be open six days a week. The location will employ two persons with Alicia Rios-Marquez working full time. Ms. Rios-Marquez informed me that they are planning on leasing an area for gaming machines and that they may have a DJ or

live music on occasion. There will be no food service other than bar snacks but expansion into the next suite with a kitchen was noted as a possibility.

- **Results of background:** The background for Alicia Rios-Marquez was completed which consisted of DMV records, law enforcement agency checks, Nevada criminal history, credit report and fingerprint responses from the FBI and State of Nevada. Results showed that Ms. Marquez was arrested twice, once in 1988 and once in 2019 and that no charges were filed or the charges were dismissed. Ms. Marquez did however fail to list the 1988 arrest on her application which she said she forgot about and that the charge was dismissed.

In order for the Sheriff's Office to complete the background for Alicia Rios-Marquez as the liquor manager for Miami Vibes I requested an updated payment plan regarding her overdue Nevada tax payments. I initially left a message with Alicia Marquez on January 10, 2022, with no response but was able to contact her on January 11th. During that call Ms. Marquez stated she would be able to promptly provide the information as requested. On January 27th I had not heard back from Ms. Marquez and therefore left another message regarding the documents and again have not yet received a response.

The background on Ms. Marquez began in March of 2021 and has consistently been placed in a "wait mode" due to her non responses throughout the background process. Due to Ms. Marquez not responding to the latest request for documentation the background has been suspended and is considered incomplete. The background packet is being sent to the CCSO Records Division for filing.
