**Agenda Title:** For Possible Action: Discussion and possible action regarding a proposed resolution and

agreement ("Resolution") for the Nevada Department of Transportation ("NDOT") to

relinquish and transfer to Carson City portions of cul-de-sacs at Monk Court and Hospitality Way that fall within or about Carson City Assessor's Parcel Number ("APN") 002-763-01.

Staff Summary: NDOT owns APN 002-763-01, and it plans to dispose of it. Staff has requested that, prior to disposal, NDOT relinquish the existing cul-de-sacs on or adjacent

to that parcel for City right-of-way. City staff has determined the rights-of-way are

necessary for emergency vehicle access.

#### Background/Issues & Analysis

Nevada Revised Statutes ("NRS") NRS 408.527 allows NDOT to relinquish rights-of-way to local governments, provided: (1) NDOT and the local government enter into a written agreement; and (2) the local government consents to the relinquishment by resolution. The Resolution is intended to fulfill both requirements.

In July 2018, NDOT conveyed APN 002-762-02, south of Hospitality Way, to a private party via a Quitclaim Deed recorded as Document No. 487118. NDOT excluded the southern portion of the Hospitality Way cul-de-sac from that conveyance and has maintained ownership. The Resolution would relinquish the south portion of the Hospitality Way cul-de-sac to the City.

APN 002-763-01 is located between Monk Court and Hospitality Way along the Interstate 580 right-of-way near Arrowhead Drive. The 1.81 acre parcel is zoned retail commercial and is surplus right-of-way that NDOT plans to dispose of. APN 002-763-01 includes the north portion of the Hospitality Way cul-de-sac and the Monk Court cul-de-sac. Staff requested that NDOT relinquish the portions of this land containing these existing cul-de-sacs before disposing of the parcel because the cul-de-sacs are necessary for emergency vehicle access and turnaround. NDOT has agreed to relinquish the cul-de-sacs to the City.

If the City approves the Resolution, it will then go to the NDOT Board of Directors for review and consideration, and the cul-de-sacs will be relinquished to the City if the NDOT Board agrees to the Resolution.

WHEREAS, the State of Nevada, Department of Transportation, hereinafter called the Department, desires to relinquish portions of IR-580 lying within Carson City, State of Nevada, extending from Approximate Milepost I-580-CC-007.572 to Approximate Milepost I-580-CC-007.584 (southerly portion of Hospitality Way cul-de-sac), from Approximate Milepost I-580-CC-007.579 to Approximate Milepost I-580-CC-007.591 (northerly portion of Hospitality Way cul-de-sac), and from Approximate Milepost I-580-CC-007.671 to Approximate Milepost I-580-CC-007.686 (southerly portion of Monk Court cul-de-sac), a distance of approximately 0.034 miles, said right-of-way is delineated and identified as Parcels I-580-CC-007.573 XS1, I-580-CC-007.579 XS1 and I-580-CC-007.671 XS1 on EXHIBIT "A" attached hereto and made a part hereof; and


WHEREAS, the Carson City Board of Supervisors State of Nevada, desires that the aforesaid portions of said highway be relinquished to Carson City; and

WHEREAS, Carson City has requested the relinquishment of aforesaid portions of highway for the purpose of a transportation facility; and

WHEREAS, Carson City has agreed to accept the relinquishment of said right-of-way for the aforesaid portions of IR-580.

NOW THEREFORE be it resolved that the Carson City Board of Supervisors, does in consideration of

the actions of the Department as set forth herein, hereby consent to the State of Nevada, Department of Transportation, Board of Directors, relinquishing to Carson City those portions of IR-580 lying within the Carson City, State of Nevada, extending from Approximate Milepost I-580-CC-007.572 to Approximate Milepost I-580-CC-007.584 (southerly portion of Hospitality Way cul-de-sac), from Approximate Milepost I-580-CC-007.579 to Approximate Milepost I-580-CC-007.591 (northerly portion of Hospitality Way cul-de-sac), and from Approximate Milepost I-580-CC-007.671 to I-580-CC-007.686 (southerly portion of Monk Court cul-de-sac), a distance of approximately 0.034 miles, said right-of-way is delineated and identified as Parcels I-580-CC-007.573 XS1, I-580-CC-007.579 XS1 and I-580-CC-007.671 XS1 on EXHIBIT "A" attached hereto and made a part hereof.




