AGENDA ITEM 4.A: For Possible Action: Discussion and possible action regarding an application for a Dining Room with Hard Liquor License (LIQUOR-006932-2022) with John Procaccini as the liquor manager for Nashville Social Club Ventures, LLC dba Nashville Social Club Carson City located at 1105 S Carson Street, Carson City, NV 89701.

Recommendation: To approve an application for a Dining Room with Hard Liquor License with John Procaccini as the liquor manager for Nashville Social Club Ventures, LLC dba Nashville Social Club Carson City at 1105 S Carson Street, Carson City, NV 89701 subject to the following approval:

- 1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.**
- 2. Alcohol sold must come from approved sources.**
- 3. The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.**
- 4. Construction of facility completed according to plans approved by the health authority.**
- 5. No changes to bar set up may be made without approval from health authority.**
- 6. Alcohol served in music venue must be served out of disposable cups.**

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Nashville Social Club Ventures, LLC dba Nashville Social Club Carson City to have a Dining Room with Hard Liquor license with John Procaccini as the liquor manager. The business is a full-service restaurant that will host live music and

special events. The business is scheduled to open soon. It is located at 1105 South Carson Street, and the business license is number BL-006909-2021.

The Sheriff's Office did an inspection of said location on 5/5/2022 and did not note anything of concern. The Sheriff's Office did a background investigation and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval subject to the above conditions.

The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for the Nashville Social Club.

- **Background of premises:** The Nashville Social Club is a new business that will be located at 1105 S. Carson St. The property has been vacant and was last occupied by Flavors of India who had relocated to another location. Mr. Procaccini anticipated that the Nashville Social Club would be open for business in May of 2022.
- **Financial arrangements:** Mr. Procaccini and his wife are investing approximately \$650,000 to remodel, equip and furnish the business location. The investment is being financed with personal monies and with monies from an additional business that Mr. Procaccini has an interest in. The Procaccini's will also have a monthly lease on the property.
- **Method of operation:** The Nashville Social Club will be open for lunch and dinner and will employ twelve to twenty persons, both full and part time. The restaurant will operate as a full-service restaurant with a large dining room, a lounge/bar area serving beer, wine and liquor, an atrium area, and a multi-purpose room. The multi-purpose room will host banquets, music events and other special events, which may include sales of entry tickets at times. In addition, Mr. Procaccini plans on having a retail area offering boutique and craft style vendors. The owners will manage certain aspects of the business but plan on hiring a General Manager to oversee the daily operations.
- **Results of background:** The background for John Joseph Procaccini, consisting of DMV records, local agency checks, Nevada criminal history query, credit report and fingerprint responses did not find any disqualifying information based on CCMC 4.13.125.
