**AGENDA ITEM 4.B: For Possible Action: Discussion and possible action regarding an application for a Tavern/Bar Liquor License (LIQUOR-007172-2022) with Vilma J Avalos Ortiz as the liquor manager for Vilma J Avalos Ortiz (Sole Proprietor) dba Miami Vibes located at 248 E Winnie Lane, Carson City, NV 89706.**

**Recommendation: To approve an application for a Tavern/Bar Liquor License with Vilma J Avalos Ortiz as the liquor manager for Vilma J Avalos Ortiz (Sole Proprietor) dba Miami Vibes at 248 E Winnie Lane, Carson City, NV 89706 subject to the following approval:**

1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
2. Alcohol sold must come from approved sources.
3. The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.
4. An approved Health Permit with pre-opening inspections.
5. Use of commercial equipment only.
6. No changes to bar set up may be made without approval from the health authority. All handwashing sinks and dump sinks must be properly used according to the FDA Food Code and NAC 446.
7. Adherence to FDA Food Code and NAC 446 for operational purposes.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Vilma J Avalos Ortiz (Sole Proprietor) dba Miami Vibes Carson City to have a Tavern/Bar Liquor license with Vilma J Avalos Ortiz as the liquor manager.

The business is scheduled to open this summer. It is located at 248 E Winnie Lane, and the business license number is BL-007171-2022.

The Sheriff's Office did an inspection of said location on 5/5/2022 and did not note anything of concern. The Sheriff's Office did a background investigation and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval subject to the above conditions.



The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for Miami Vibes.

- **Background of premises:** Miami Vibes will be located at 248 E Winnie Lane and is scheduled to open in June or July of this year. The location of the Bleu Café' was split into multiple suites and one of the suites will be occupied by Miami Vibes. The new owner, Ms. Avalos Ortiz, informed me the two former applicants for Miami Vibes are longer associated with this business and that she has cut any business ties with them.
- **Financial arrangements:** Ms. Avalos Ortiz, is investing approximately \$20,000 of her personal money to equip and stock the bar. She had previously loaned money to the former applicants which paid for some of the equipment that has already been put in place. Ms. Ortiz has a lease agreement for two years and two months and will pay a monthly lease amount.
- **Method of operation:** Miami Vibes will operate as a bar selling beer, wine and hard liquor and will have live music or a DJ at times. There will be no food service other than offering snacks. The bar will be open six days a week and Ms. Avalos Ortiz' husband will be working in the bar full time. Ms. Ortiz who is employed full time elsewhere may transition from her current employment to the bar once it is established. She may employ additional persons through an employment agency.


- **Results of background:** The background for Vilma Janet Avalos Ortiz consisting of DMV records, law enforcement agency checks, Nevada criminal history, credit report and fingerprint responses from the FBI and State of Nevada did not find any disqualifying information based on CCMC 4.13.125.
