Recommendation: To approve an application for a Dining Room with beer and wine Liquor License with Xiaojuan Yu as the liquor manager for Shunfa of Carson City LLC dba Panda Kitchen and Sushi at 1986 E William Street, Carson City, NV 89701 subject to the following approval:

- 1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
- 2. Alcohol sold must come from approved sources.
- 3. The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.
- 4. Serving of beer and wine only.
- 5. No changes may be made without approval from health authority.
- 6. No beverage waste should be dumped in handwashing sinks.
- 7. Adherence to FDA Food Code and NAC 446 for operational purposes.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Shunfa of Carson City LLC dba Panda Kitchen and Sushi to have a Dining Room with beer and wine Liquor license with Xiaojuan Yu as the liquor manager. The business is currently operating under the previous owner's liquor license LIQUOR-004786-2020.

The Sheriff's Office did an inspection of said location on 5/11/2022 and did not note anything of concern. The Sheriff's Office did a background investigation and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval subject to the above conditions.

Panda Kitchen Yu, Xiaojuan

The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for Panda Kitchen.

- <u>Background of premises:</u> Panda Kitchen is located at 1986 E William St. and is an
 established business. The former owner sold the business to her mother who was
 scheduled to take over operations on April 1st. There is a management agreement
 indicating the seller, Huiwen Chen, will assume responsibility for any liquor liabilities until
 Xiaojuan Yu is issued her own license.
- <u>Financial arrangements:</u> Ms. Xiaojuan Yu is purchasing the business for \$30,000 and will be making monthly payments directly to her daughter, the seller.
- Method of operation: Panda Kitchen is a full-service restaurant offering Oriental cuisine and Sushi and is open daily for lunch and dinner. Ms. Yu will be employing the same staff and will be working in the restaurant full time. The restaurant currently offers sales of beer and wine and accommodates seating for about 82 people.
- Results of background: The background for Xiaojuan Yu consisting of DMV records, law enforcement agency checks, Nevada criminal history, credit report and fingerprint responses from the FBI and State of Nevada did not find any disqualifying information based on CCMC 4.13.125. A location inspection was also performed by the Sheriff's office on April 27, 2022. A staff member was spoken to while Ms. Yu was present, as Ms. Yu does not speak English.
