The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for China Palace.

- Background of premises: China Palace will be a new restaurant located at 3135 Hwy 50 E. The location was previously occupied by China Chef and the owners vacated the business location after their lease agreement expired. Per the property management company, the building is currently being renovated and they have a lease agreement with the new occupant. Mr. Verde anticipated the restaurant opening sometime in May.
- Financial arrangements: Joshua Verde, the sole business owner, noted that he is not investing any money. He stated that he is leasing the business location on a monthly basis and would be using what equipment and supplies are in the building.
- Method of operation: China Palace will be open for lunch and dinner offering oriental cuisine with sales of beer and wine. Mr. Verde indicated he may have five employees and said the restaurant will be managed daily by his father Cesar Verde. Joshua Verde works full time elsewhere and stated that he would stop in at the restaurant each day prior to beginning his work shift elsewhere.
- Results of background: The background for Joshua Jesus Verde Cabrera consisting of DMV records, law enforcement agency checks, Nevada criminal history, credit report and fingerprint responses from the FBI and State of Nevada did not find any disqualifying information based on CCMC 4.13.125. A location check was performed by the Sheriff's office on April 27, 2022; the business appeared to be under remodel with no occupants.
