Carson City Board of Supervisors,

There is no legitimate reason to amend the municipal code to allow an additional marijuana dispensary in Carson City. In addition to the two in Carson City there are two more marijuana stores within a 20 minute drive in Mound House and Washoe. Furthermore, another store would not increase city revenue, it would simply divide the "pie" into smaller pieces.

The easy access to pot has increased the burden on law enforcement as the Sheriff's Department has had to add another K-9 Unit to sniff out drugs in school lockers – an occurrence that has increased significantly. There is no way to keep marijuana out of the hands of minors and adding another source to purchase pot strengthens the message of societal acceptance.

The only people who would benefit from this are the applicants. It provides no benefit to our community, nor our children.

Please do not change the existing limit.
