<u>Recommendation</u>: Deny the Dining Room with Hard Liquor License with Emily Gonzalez as the liquor manager for Ruben Cortez Gonzalez dba Don Jose Bar & Grill at 1301 N Carson Street, Carson City, NV 89701, based on the finding that Don Jose Bar & Grill is closed and is no longer operating.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Ruben Cortez Gonzalez dba Don Jose Bar & Grill to have a Dining Room with Hard Liquor License with Emily Gonzalez as the liquor manager. Following application for the liquor license, the business closed. Staff is recommending denial of the liquor license because the business in no longer operating.

Applications have been made by the new owner for this business location (1301 N Carson Street). The new applications will be considered at a future meeting following the required investigations.
