AGENDA ITEM 4.A: For Possible Action: Discussion and possible action

regarding an application for a Packaged Liquor License (LIQUOR-007487-2022) with Satish Kumar as the liquor manager for Carson Petroleum Inc dba Eagle Gas and Food located at 1360 S Carson Street, Carson City, NV 89701.

<u>Recommendation</u>: To approve an application for a Packaged Liquor License with Satish Kumar as the liquor manager for Carson Petroleum Inc dba Eagle Gas and Food located at 1360 S Carson Street, Carson City, NV 89701 subject to the following conditions of approval:

- 1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
- 2. Alcohol sold must come from approved sources.
- 3. The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.
- 4. Facility is approved for packaged alcohol only.
- 5. Adherence to FDA Food Code and NAC 446 for operational purposes.
- 6. Remodeling and/or new construction must be reviewed by health authority to ensure compliance.
- 7. All gaps to the outside must be sealed to inhibit pest entry.
- 8. The applicant must obtain a pest control company for routine visits.
- 9. Facility must be deep cleaned.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Carson Petroleum Inc dba Eagle Gas and Food to have a Package Liquor License with Satish Kumar as the liquor manager.

The Sheriff's Office did a background investigation and did not find any disqualifying information based on CCMC 4.13.125.

The Health Department has reviewed the application and recommends approval based on the above conditions being met.

The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for Eagle Gas & Food.

- <u>Background of premises:</u> Eagle Gas & Food is located at 1360 S Carson St. and was operating as a Sinclair gas station and mini mart. The property was seized by the state of Nevada as the owner was delinquent on monies owed to the state.
- Financial arrangements: Mr. Kumar and his business partner Inderdeep Singh are investing approximately \$1,931,000 for the purchase of real and personal property. The state is liquidating the property and the sale is scheduled to close on or before September 20th.
- Method of operation: Eagle Gas & Food will operate as a gas station and convenience store and will be open daily. The store will be selling packaged liquor, beer, and wine as well as tobacco products. Mr. Kumar will be managing the business and stated he will be employing two to three persons.
- Results of background: The background for Satish Kumar consisting of DMV records, law enforcement checks, Nevada criminal history, credit report and fingerprint responses did not find any disqualifying information based on CCMC 4.13.125.
