RE: Item 9C, Drainage Easement

The accompanying material provides an update to Exhibit A to this easement. In reviewing the easement area it was determined that the area specified by Exhibit A to the April 2, 1999 Agreement for Grant of Easement covered approximately half of the area needed for the drainage easement. The accompanying documents update the area of the easement to cover the entire width of the drainage.
