Subject Title: Action to approve a request from the American Cancer Society to waive the rental fee for the Parks and Recreation Department's mobile stage for "Relay for Life" events to be held June 30 and July 1, 2007, in Fallon, Nevada, and July 21 and 22, 2007, in Carson City.

Staff Summary: The American Cancer Society annually conducts "Relay for Life" events in order to promote cancer awareness and raise money for cancer prevention programs. This year the American Cancer Society will be renting the mobile stage for two events. The first will be held in Fallon, Nevada, at the Churchill County Junior High School on June 30 and July 1. The second event will be held on July 21 and 22 at the Carson High School football stadium. The American Cancer Society is requesting a waiver of the rental fees for the stage. Waiving the fees allows the Society to retain more money for their programs. This action does not include waiving the cleaning deposit fees of \$604 nor the administration fees of \$14.
